The "First Lady" Fashion Show

I am absolutely delighted to report that our "First Lady's Fashion Show" was monumentally successful! One hundred and eleven people attended, and we raised serious money for our many worthy causes. In case you are wondering what those are, I can tell you that each year the club

awards a partial college scholarship to a senior graduating from Incline High School. We also contribute money to "We the People" (a club at Incline High School for students interested in learning about American government), "Red White and Tahoe Blue," the Veterans' Guest House, "Wreaths Across America," "Kids & Horses" (a nonprofit equine therapy program), and the Republican Women of Northern Nevada PAC. We also donate gifts in kind to the Incline Village Library and the Incline Village Community Hospital Auxiliary. All this even though the club is not a 501 (c) (3) organization and contributions to it are not tax deductible!

The Fashion Show was truly a group effort by dozens of our club members as well as the non-member people and organizations that our members recruited to donate gifts for the silent auction. We are deeply grateful to everyone who helped, participated and attended.

The Republican Candidates for IVGID Forum

I think everyone understands what an important and controversial election this is to the Incline Village General Improvement District (IVGID) Board of Trustees. Three Republicans are running for two seats. They are (in alphabetical order by last names): Tim Callicrate, Sara Schmitz and Kendra Wong. All are members or associate members of our club. (There is a fourth candidate, but he is a registered Democrat.) This will be a luncheon meeting on October 9th starting at 11:30 a.m. and lasting until about 1:30 p.m. at the Chateau. Each of the three Republican candidates will be given 10 minutes to state his or her platform or otherwise campaign for the office – or if they prefer, to call on members of the audience to ask questions of them specifically. This will be followed by a 15-minute Q & A session during which members of the audience can ask questions of any or all three of the Republican candidates for IVGID. The decision of whom to vote for in this race is especially important this year, and we hope that our forum will help us all make an informed decision.

Some have asked why we are giving a public platform only to the Republicans in this race, since the seats on the IVGID Board of Trustees are "non-partisan." The short answer is that we are a Republican club that people join because they support the values of the Republican Party; and that the club exists principally to promote the election of Republicans.



ABOUT IVGID

The Incline Village General Improvement District, commonly referred to as IVGID, is a quasi-public agency established under Nevada Revised Statute, Chapter 318 and chartered to provide water, sewer, trash and recreation services for the communities of Incline Village and Crystal Bay, Nevada. It is governed by an elected Board of Trustees which, acting on behalf of the electorate, sets policy and determines strategies for accomplishing its charter. Both Incline Village and Crystal Bay, Nevada are located within Washoe County, the entity that had the authority to create IVGID, and they are both unincorporated areas within Washoe County.

IVGID was created by Washoe County under State law (Nevada Revised Statute 318), effective June 1, 1961 (Washoe County Ordinance No. 97, Bill No. 57) as a body corporate and public and a quasi-municipal corporation in the State of Nevada. NRS 318 authorized the newlycreated District to levy taxes to pay for improvements and for five elected Trustees to set up and run the District. Within the limits of the statutes, IVGID is empowered to determine what facilities and services it should offer that will preserve or enhance the general health, safety and welfare of the community. It may set rates, tolls and fees to be charged for the provision of those facilities and services, and it may borrow or raise funds to acquire, construct and/ or provide those facilities and services to the community. Finally, IVGID has the power to levy and collect taxes necessary to sustain its operations.

About our Speaker, **Tim Callicrate,** IVGID Trustee Candidate



I am a soleowner proprietor business owner here in Incline Village where I have lived as a full-time, yearround resident since June of 1985. I have been a professional

pianist/vocalist for over 35 years. My music brought me to the area initially as an entertainer for a surprise birthday of a college friend I met at the University of Portland. Her folks flew me down from Portland for Memorial Day, 1985 and I never left!

I worked at Steven Lake Tahoe restaurant in Incline as both a waiter and manager from 1985 to February 1987 at which time I transitioned to the Hyatt to accept a staff pianist position at Hugo's on the Lake where I performed until its replacement by the Lone Eagle Grille in 1994. I continued with the Hyatt at the Lone Eagle until 1999 and have enjoyed a 31+ year affiliation with the Hyatt Corporation to this day.

I have produced three compact discs of background piano music entitled *Serenade From Tahoe* which have been steadily climbing the charts on Pandora, iTunes, Amazon and CD Baby.

My political interests began at the University of Portland where I served in the Senate of the Associated Students of the University of Portland (ASUP) and was elected Student Body President for my Senior year, 1982-1983. Flash forward 23 years to Sierra Nevada College, and I was once again elected as the Student Body President...a much different but equally rewarding experience to say the least!

As an IVGID Trustee, I was given the honor to serve as the Board Chair (1999), Vice Chair

(1998/2000) and Secretary (1997). During my tenure on the Board, my fellow officers and I were tasked with several important issues: the hire of a new General Manager, a Management Audit, a Wages and Compensation Audit, a complete reorganization of the District, replacement of Burnt Cedar Beach facilities, all beach fencing and guard houses, renovation of the Village Green, sewer/water main redundancies and defensible space initiatives. One of our final accomplishments was the completion of the District's first-ever Strategic Plan that was to be used by successive Boards as a guide and framework to aid in stewarding the District through the next several years. This, unfortunately, never took place and we find ourselves revisiting many of the problems and issues from 20 years ago!

In my educational endeavors I earned a BS in Communications Management from the University of Portland in 1983 and both a BS in Entrepreneurship and a Master of Arts in Teaching (MAT) from Sierra Nevada College in 2012.

Through the years as a resident of Incline Village I have made it a point to volunteer in and/or support a multitude of local civic organizations such as Washoe County School music programs, ICAN Run, Incline Ice Foundation, St. Francis of Assisi Catholic Church, Sierra Nevada College, IV/CB Chamber of Commerce Incline 2000, Shakespeare at Sand Harbor, Relay For Life (26 year Survivor of Stage 4 non-Hodgkin's Lymphoma), Children's Cabinet, Parasol Foundation, Red White and Tahoe Blue, and Thunderbird Lodge (16 year Docent).

My current tenure on the IVGID Board has caused me great concern. The majority of the Board has continually abdicated its responsibility of oversight and capitulated its authority to a feckless General Manager and a legal counsel woefully bereft of the knowledge of the NRS statutes which govern our general improvement district.

It is time to elect Sara Schmitz and reelect Tim Callicrate to rein in the profligate spending, suppression of public records and abrogation of governance inherent in the current majority of the IVGID Board!

The High Stakes for the Next Supreme Court Justice

Why is the appointment of Trump nominee Brett Kavanaugh so important at this juncture in American history? This was the question addressed by Arizona Supreme Court Justice Clint Bolick at a recent luncheon held in Incline Village.



Nearly a dozen IVCBRW members had a chance to attend and listen to this presentation sponsored by the Hoover Institution, a public policy think tank located on the campus of Stanford University. Justice Bolick is a Research Fellow with Hoover.

Justice Clint Bolick

Justice Bolick shared with us four reasons why this appointment is so pivotal.

First and foremost is the long tenure Supreme Court Justices now enjoy since their average age is 52 and most are likely to live to 85 or more years. This gives them the opportunity to opine as the final voice on U.S. Constitutional matters for 33 years or more. Clint Bolick pointed out that when the framers of the Constitution wrote that justices would be appointed for a lifetime, most of the early Supreme Court nominees were older than the average life expectancy in the late 1700s and many only served a short period of time. Little did the framers of our constitution predict that lifetime appointments would endure so long in the 21st century.

Second, as the powers of the Federal Government have grown, the U.S. Supreme Court has moved away from its original task to limit the other two branches of government. They now rewrite laws which has had a profound impact on the scope and impact of the court. Our speaker pointed out, for example, that it took 160 years for the US Code (a compilation of all US laws) to reach 11,000 pages. It took only another 40 years for the Code to quadruple in size. Third, the science of appointing judges has become very sophisticated so that we can better predict how they will rule on pending and future cases. Justice Bolick described the detailed analysis that organizations, such as the Federalist Society, undertake to profile sitting judges and lawyers. This means that personal ideology becomes a major factor, particularly as the body politic of the USA has become more divided.

Fourth is the fact that the balance of the US Supreme Court will be determined by the next justice. Bolick pointed out that the nomination and appointment of Associate Justice Neil Gorsuch to the US Supreme Court was less controversial since he was replacing a known conservative, former Associate Justice Scalia. However, Kavanaugh is being appointed to replace the swing voter on the court – Associate Justice Anthony Kennedy. Kavanaugh is an originalist who tends to regard the strict wording of the US Constitution as binding, a far cry from Justice Kennedy who at one point said there was a "right to dignity" in the Constitution.

Thus the stakes are indeed high, particularly when it is likely there will be 5-4 decisions to arrest the growth of the administrative state. Our speaker opined that he did not feel social issues such as Roe versus Wade, gay marriage, or Obamacare will likely be overturned. But he does believe that pivotal issues surrounding private property rights, school choice, racial preferences, and the death penalty will be addressed.

Justice Bolick was cautiously optimistic that President Trump's nominee, Brett Kavanaugh, will be confirmed before the end of the year. He urged each of us to ensure that Republican Senators win election or reelection, since the appointment of both Supreme Court and lower court judges hangs in the balance and will impact us for the foreseeable future.

A final word about the Hoover Institution, founded in 1919 by President Herbert Hoover, a member of Stanford's first graduating class. This institution advances principled, workable public policies that champion individual, economic and political freedom. Hoover Institution has had a significant impact on



public policies at the Federal and State level and has key research fellows in Republican Administrations, including the Trump Administration. 

36 of 40 key districts will decide control of the House of Representatives.

I n a troubling finding that would have been unheard of at the end of World War II, Gallup recently reported that less than one-third of Democrats were extremely proud of being Americans. Prior to the 1960s, Democrats, like their Republican counterparts, overwhelmingly saw their country's two-party capitalist system as a force for good in the world. Since then, little by little the Democratic Party has undergone a revolutionary change nearly unnoticed by most Americans.

As reported by *Politico*, a 2016 survey of Democrat primary voters



found that Democrats, in every demographic group, have gravitated in large numbers toward the teachings of Karl Marx. The survey reported that nearly 6 out of 10 Democrat primary voters favored socialism over capitalism. Another 2016 survey in Iowa by *Bloomberg/ Des Moines Register*, found that

43 percent of prospective Democrat caucus goers described themselves as "socialist."

BACKGROUND OF COMMUNISM – In November 1847, Karl Marx co-authored a written party platform for a workmen's association. His revolutionary manuscript, entitled The Communist Manifesto, called for using victim vs. oppressor ideology *(identity politics)* to achieve political power; abolishing private property rights and inheritance rights; excessively punitive income taxes; driving religion from the public arena and denigrating traditional morality; teaching citizens to look to government, rather than God, for their daily salvation; indoctrinating school children with socialist propaganda; subordinating individual rights in favor of group rights; and, abolishing all countries and nationalities *(open borders)*. To varying degrees, each of those goals has been embraced, overtly or otherwise, by the political left in America.

Any of this sound familiar today? The collectivist theories of Karl Marx have left an unbroken trail of failure and oppression wherever they have been tried; yet infatuation with his socialist-cum-communist dogma has grown by leaps and bounds in the modern Democratic Party. Remember what former Chairman of the Council of People's Commissars of the Soviet Union, Vladimir Lenin, said . . . "the goal of socialism is communism."


