STOP Ranked Choice Voting in Nevada!

What is Ranked Choice Voting? An UNCONSTITUTIONAL INITIATIVE from the radical left that attempts to reinvent "plurality of votes," and which can only happen by changing Nevada's Constitution. It is "proportional" voting for which your vote can be assigned to a candidate you did not vote for. This is language from the Proposed Constitutional Amendment: "The candidate with the fewest votes is eliminated. Votes cast for the eliminated candidate shall cease counting for the eliminated candidate and shall be added to the totals of each ballot's next-highest-ranked continuing candidate or considered an inactive ballot."

H.R. 127 – A Bill Designed to Express Hostility Toward Law-Abiding Gun Owners

his bill, which has not yet been scheduled for a committee hearing (and currently has zero cosponsors) shows how far gun control advocates will go in attacking the right to keep and bear arms.

HR 127 establishes a nationwide gun registry *that is* searchable by the general public, mandates licensing to own or possess a firearm and requires a psychological evaluation prior to obtaining such a license, and institutes magazine and gun bans.

This is one of the most sweeping attacks on your Second Amendment rights ever proposed. It would:

- Establish a publicly-searchable gun registry containing your most private information;
- Require you to petition an anti-gun Attorney General for a "license" to possess firearms and ammunition;
- Further force you to obtain "firearms insurance" from the federal government at a cost of \$800 PER YEAR;
- Ban numerous rifles, AR pistols, shotguns, .50 (or greater) ammo, and any magazine with a capacity of over 10 rounds; and
- Slap gun owners with mandatory minimum prison sentences and fines for so-called "violations" of this proposed legislation.

All gun control bills share the same basic goal: a world in which fewer people own firearms. Some bills simply ban certain types of firearms or ammunition outright. Others place obstacles in the path of owning firearms or ammunition to make them more difficult and expensive to obtain, thereby shrinking the market for them. The

fundamental flaw of these approaches is that they treat all law-abiding firearm owners as would-be criminals, when the reality is that most firearm-related assaults and homicides are committed by people who completely disregard the law, including laws against taking human life.

H.R. 127 would effectively price lawful firearm ownership out of reach for many of the poorest and most vulnerable Americans, including many seniors.

ast month, New York Congresswoman
Carolyn Maloney summoned firearms
manufacturers to testify before the House
Committee on Oversight and Government Reform
committee that she chairs. Ruger CEO Chris Killoy
and Daniel Defense's Marty Daniel appeared and
parried, as best they could, the ignorance,
misinformation and lies about the guns they make,
the companies they run, and the industry of which
they are a part.

It was every bit the star chamber affair everyone knew it would be, with committee Democrats attacking both the First and Second Amendments while smearing gunmakers with falsehoods and displaying their impressive level of ignorance about

the industry and the products gun makers produce.

One intended target, Smith & Wesson CEO Mark Smith, declined Chairwoman

Maloney's "invitation" to participate. He apparently saw no reason to subject himself or his company to the ritual abuse and smears he knew would be directed his way. Maloney didn't take the snub well. It seems that telling an endangered legislator that you won't participate in her made-for-the-media dog-and-pony show can have consequences. A few days later, Maloney issued subpoenas, hoping to extract detailed sales and marketing information from Smith & Wesson on the AR pattern rifles that she can use to harm the publicly traded company and further her goal of limiting Americans' gun rights.

Yesterday, CEO Smith fired back, issuing the following statement . . .

"A number of politicians and their lobbying partners in the media have recently sought to disparage Smith & Wesson. Some have had the audacity to suggest that after they have vilified, undermined and defunded law enforcement for years, supported prosecutors who refuse to hold criminals accountable for their actions, overseen the decay of our country's mental health infrastructure, and generally promoted a culture of lawlessness, Smith & Wesson and other firearm manufacturers are somehow responsible for the crime wave that has predictably resulted from these destructive policies. But they are the ones to blame for the surge in violence and lawlessness, and they seek to avoid any responsibility for the crisis of violence they have created by attempting to shift the blame to Smith & Wesson, other firearm manufacturers and law-abiding gun owners.

"It is no surprise that the cities suffering most from violent crime are the very same cities that have promoted irresponsible, soft-on-crime policies that often treat criminals as victims and victims as criminals. Many of these same cities also maintain the strictest gun laws in the nation.

"But rather than confront the failure of their policies, certain politicians have sought more laws restricting the 2nd Amendment rights of lawabiding citizens, while simultaneously continuing to undermine our institutions of law and order. And to suppress the truth, some now seek to prohibit firearm manufacturers and supporters of the 2nd Amendment from advertising products in a manner designed to remind law-abiding citizens that they have a Constitutional right to bear arms in defense of themselves and their families.

"To be clear, a Smith & Wesson firearm has never broken into a home; a Smith & Wesson firearm has never assaulted a woman out for a late-night run in the city; a Smith & Wesson firearm has never carjacked an unsuspecting driver stopped at a traffic light. Instead, Smith & Wesson provides these citizens with the means to protect themselves and their families.

"We are proud of our 170-year history. We are proud of the commitment of our employees to making a quality product. We are proud to provide law-abiding citizens and law enforcement – our customers – with the tools to provide for their security and independence. We are proud of our responsible business practices.

"We will continue to work alongside law enforcement, community leaders and lawmakers who are genuinely interested in creating safe neighborhoods. We will engage those who genuinely seek productive discussions, not a means of scoring political points. We will continue informing law-abiding citizens that they have a Constitutionally-protected right to defend themselves and their families. We will never back down in our defense of the 2nd Amendment."

Laxalt Releases New Television Response Ad on Cortez-Masto's Gutter Politics

Recently Nevada U.S. Senate candidate Adam Laxalt unveiled his second general election ad, titled "Gutter Politics." The commercial details how Senator Cortez-Masto's defamatory ads have been fact checked and deemed false, misleading, and full of defamatory claims that don't add up by several news outlets.

'Gutter Politics' will run on cable and broadcast across the state of Nevada.

SCRIPT FOR AD:

"Catherine Cortez-Masto is desperate -- spending millions attacking Adam Laxalt's family and childhood, and lying about his record."

"Pathetic"

"The *Reno Gazette Journal* fact-checker labeled Cortez-Masto's ads false."

"The Washington Post called Cortez-Masto's ads especially bad, misleading, and full of false claims that don't add up."

"Gutter politics can't hide Cortez-Masto's record of failure."

"Nevada deserves results, not more lies."

BACKGROUND:

One of Cortez-Masto's commercials, airing first on August 2nd, accused Adam Laxalt of protecting opioid manufacturers from lawsuits during his time as Nevada's Attorney General. In reality, Adam worked with a bipartisan multi-state legal initiative to sue opioid manufacturers.

Cortez-Masto's second ad, airing first on August 13th, claimed that Adam Laxalt refused to sue

pharmaceutical companies that donated to his campaign for Attorney General. **In reality**, Adam sued Perdue Pharma in 2018 after receiving \$2,750 in contributions from Perdue between 2014 and 2016. Adam has never been afraid to sue bigpharma, regardless of which party they donate to.


The *Washington Post* fact-checkers awarded Cortez-Masto's ads a total of **seven** "Pinocchios" for their defamatory claims.

WaPo's fact check came just two days after the *Reno Gazette Journal* labeled Cortez-Masto's previous attack ad, "False."

Cortez Masto herself has raised millions from pharmaceutical companies. According To The Center For Responsive Politics, Between 2017 And 2022, Cortez Masto received \$217,695 from PACs and individuals in the Pharmaceuticals/Health Products Industry. According To The Center For Responsive Politics, During Cortez Masto's time leading the DSCC, the committee received \$2,342,852 from the Pharmaceuticals/Health Products Industry.

As Attorney General, Laxalt secured funding for additional drug incinerators around the state to get dangerous drugs like fentanyl off our streets.

As Attorney General, Laxalt also arranged for every law enforcement agency in the state to have naloxone as an antidote to opioids overdoses in the line of duty.





China Is Preparing To Go To War

China expert Gordon Chang makes the case that China is preparing for armed conflict – and could happen quite soon.

ast month, a Chinese entrepreneur making medical equipment for consumers told me that local officials had demanded he convert his production lines in China so that they could turn out items for

the military. Communist Party cadres, he said, were issuing similar orders to other manufacturers.

Moreover, Chinese academics privately say the ongoing expulsion of foreign colleagues from China's

universities appears to be a preparation for hostilities.

The People's Republic of China is preparing to go to war, and it is not trying to hide its efforts. Amendments to the National Defense Law, effective the first day of last year, transfer powers from civilian to military officials.

In general, the amendments reduce the role of the central government's State Council by shifting power to the CMC, the Communist Party's Central Military Commission. Specifically, the State Council will no longer supervise the mobilization of the People's Liberation Army.

As Zeng Zhiping of Soochow University told Hong Kong's South China Morning Post, "The CMC is now formally in charge of making national defense policy and principles, while the State Council becomes a mere implementing agency to provide support for the military."

In one sense, these amendments were window dressing. "Recent changes to China's National Defense Law that diminish the power of the State Council are largely political posturing," Richard Fisher of the Virginia-based International Assessment and Strategy Center told me soon after the amendments went into effect. "The Chinese Communist Party and particularly its subordinate CMC have always held supreme power over decisions regarding war and peace."

Why then do we care about the National Defense Law amendments?

The amendments, Fisher tells us, "point to China's ambition to achieve 'whole nation' levels of military mobilization to fight wars and give the CMC formal power to control the future Chinese capabilities for global military intervention."

"The revised National Defense Law also embodies the concept that everyone should be involved in national defense," reports the Communist Party's

Global Times, summarizing the words of an unnamed CMC official. "All national organizations, armed forces, political parties, civil groups, enterprises, social organizations, and other organizations should support and take part in the development of national defense, fulfill national defense

duties, and carry out national defense missions according to the law."

As Fisher told *19FortyFive* this month, "For the past 40 years, China's Communist Party has been preparing for brutal war, and now the ruling organization is accelerating its plans."

The Party, as it readies itself for combat, is leaving nothing to chance. In March, its Central Organization Department issued an internal directive prohibiting the spouses and children of ministerial-level officials from owning foreign real estate or shares registered offshore. The ban also appears to apply to such officials themselves as there are reports of their selling foreign assets. Moreover, such officials and immediate families are not, except in limited

circumstances, allowed to open accounts overseas with financial institutions.

The directive, issued soon after the imposition of sanctions on Russian officials for the "special military operation" in Ukraine, appears designed to sanction-proof Chinese officials.

Moreover, the central government is trying to sanctions-proof itself. On April 22, officials from the finance ministry and central bank met with representatives of dozens of banks, including HSBC, to discuss what Beijing could do in the event of the imposition of punitive measures on China.

The holding of the "emergency meeting," reported by the Financial Times, is ominous. "The officials and attendees did not mention specific scenarios, but one possible trigger for such sanctions is thought to be a Chinese invasion of Taiwan," the FT noted. The fact that Chinese officials held the meeting is a clear indication that Beijing is planning belligerent acts.

"Be ready for battle." That's how Hong Kong's South China Morning Post summarized Chinese ruler Xi Jinping's first order to the military of 2019. In



January of that year, he gave a major speech to the CMC on making preparations for war, and the address was then broadcast nationwide.

Foreign analysts debate whether China is going to war anytime soon. The Chinese political system has become less transparent over time, so it is not clear what senior leaders are thinking.

Yet it is clear what senior leaders are in fact doing. They are getting troops ready for another advance below the Line of Actual Control in Ladakh, preparing to seize more Indian territory in the Himalayas. They renewed, in November of last year and this June, attempts to block the resupply of a Philippine outpost at Second Thomas Shoal, in the

South China Sea. They ordered four vessels to enter Japan's sovereign water around the disputed but Japanese-controlled Senkaku Islands in the East China Sea in late July. They are directing continual provocations around Taiwan, including a violation of the island's sovereign airspace in early February.

And there is something else that is unmistakable: Xi and senior leaders are getting China's citizens ready for war.

History of Labor Day

Observed the first Monday in September, Labor Day is an annual celebration of the social and economic achievements of American workers. The holiday is



rooted in the late nineteenth century, when labor activists pushed for a federal holiday to recognize the many contributions workers have made to America's strength, prosperity, and well-being. Before it was a federal holiday, Labor Day was recognized by labor activists and individual states. After municipal ordinances were passed in 1885 and 1886, a movement developed to secure state legislation. New York was the first state to introduce a bill, but Oregon was the first to pass a law recognizing Labor Day, on February 21, 1887. During 1887, four more states -Colorado, Massachusetts, New Jersey and New York - passed laws creating a Labor Day holiday. By the end of the decade Connecticut. Nebraska and Pennsylvania had followed suit. By 1894, 23 more states had adopted the holiday, and on June 28, 1894, Congress passed an act making the first Monday in September of each year a legal holiday.





The First Labor Day: Daze - Pride, Chaos and Kegs

n the morning of September 5, 1882, a crowd of spectators filled the sidewalks of lower Manhattan near city hall and along Broadway. They had come early, well before the Labor Day parade marchers, to claim the best vantage points from which to view the first Labor Day parade. A newspaper account of the day described "...men on horseback, men wearing regalia, men with society aprons, and men with flags, musical instruments, badges, and all the other paraphernalia of a procession."

The police, wary that a riot would break out, were out in force that morning as well. By 9 a.m., columns of police and club-wielding officers on horseback surrounded city hall.

By 10 a.m., the Grand Marshall of the parade, William McCabe, his aides and their police escort were all in place for the start of the parade. There was only one problem: none of the men had moved. The few marchers that had shown up had no music.

According to McCabe, the spectators began to suggest that he give up the idea of parading, but he

was determined to start on time with the few marchers that had shown up. Suddenly, Mathew Maguire of the Central Labor Union of New York (and probably the father of Labor Day) ran across the lawn and told McCabe that two hundred marchers from the Jewelers Union of Newark Two had just crossed the ferry — and they had a band!

Just after 10 a.m., the marching jewelers turned onto lower Broadway — they were playing "When I First Put This Uniform On," from Patience, an opera by Gilbert and Sullivan. The police escort then took its place in the street. When the jewelers marched past McCabe and his aides, they followed in behind. Then, spectators began to join the march. Eventually, there were 700 men in line in the first of three divisions of Labor Day marchers. Final reports of the total number of marchers ranged from 10,000 to 20,000 men and women.

With all of the pieces in place, the parade marched through lower Manhattan. The New York Tribune reported that: "The windows and roofs and even the lamp posts and awning frames were occupied by persons anxious to get a good view of the first parade in New York of workingmen of all trades united in one organization."

At noon, the marchers arrived at Reservoir Park, the termination point of the parade. While some returned to work, most continued on to the post-parade party at Wendel's Elm Park at 92nd Street and Ninth Avenue; even some unions that had not participated in the parade showed up to join in the post-parade festivities that included speeches, a picnic, an abundance of cigars, and "Lager beer kegs... mounted in every conceivable place."

From 1 p.m. until 9 p.m. that night, nearly 25,000 union members and their families filled the park and celebrated the very first, and almost entirely disastrous, Labor Day.
