





The National Popular Vote vs. the Electoral College

Some people advocate for the National Popular Vote with the cry that "every vote counts." Not exactly.

The Founding
Fathers, in their
wisdom,
determined that
the President
should be chosen
by electors
through a



process called the Electoral College. In this process each state gets as many electors as it has members of Congress (House and Senate). Including Washington, D.C.'s three electors, there are currently 538 electors in all. The voters in each state choose electors to serve in the Elector College. After individual voters cast their ballots for president, the vote goes to a statewide tally. In 48 states and in Washington, D.C., the winner gets all the electoral votes for that state. Maine and Nebraska assign their electors using a proportional system. A candidate needs the vote of at least 270 electors (out of a total of 538), more than half of all electors, to win the presidential election. This process gives weight to all states, not just the states with the highest populations (California and New York).

The National Popular Vote is a process by which all electoral votes are awarded to whichever presidential ticket wins the overall popular vote in the 50 states and the District of Columbia. In this scenario, those states with the most voters would determine the outcome of the presidential election, and those states with fewer voters (like Nevada) would have minimal impact (if any) on the outcome of the presidential race. Rural counties and states would have minimal impact (if any) on the presidential election. The National Popular Vote would result in Democrat wins and it is believed by many that it will put an end to the Republican Party.

How Nevada can Avoid California's Insurance Disaster

I used to own property in California, as I suspect many of you did, or may still do. Most of us are painfully aware that California has an insurance crisis that is leaving thousands of homeowners without coverage. State Farm and Allstate have announced they will no longer sell new insurance policies in that state. Farmers Insurance is capping the number of new policies it will sell. And Chubb and AIG are curtailing their California operations.

These announcements come after several years of homeowners being informed their current insurer will not renew their policy. Insurance agents describe long-term clients in tears in their offices because no one will insure their most valuable asset – their house. Companies are no longer writing policies because it has become increasingly expensive, if not cost prohibitive, for insurance companies to operate in that state.

So how did California get this way? Governor Gavin Newsom conveniently blames "climate change," but the causes go much deeper and reside on the doorstep of politicians like Newsom who have made the situation worse.

First, Proposition 103 passed in 1988 made the California Insurance Commissioner an elected office. This means, he/she is inclined to make publicly popular decisions (especially when they

aim for higher office) such as keeping premiums artificially low. Fortunately, in Nevada the Insurance Commissioner is an appointed position buffered by a higher appointed official, hopefully allowing our Commissioner to make tough business -sensitive decisions to keep insurance firms writing in our state

Second, severe wildfires in California over the past five years have played a role in hurting the insurance situation, but this is due to mismanagement of their forests. California has mostly rejected controlled burning and fuels reduction to remove underbrush, resulting in unnatural forests that are timber-boxes. Further, failure to allow modern land management through logging operations has left their forests full of dead and dying trees.


In contrast, in Nevada, the North Lake Tahoe Fire Protection District should be commended on the extensive work they have done to remove dead trees, underbrush, thin our forest floor growth, and create fire breaks. Over 1,200 acres have already been addressed in Incline Village, and their cooperation with local officials and homeowner groups will help increase the acreage that meets defensible space requirements. Fire-safe communities are better able to both retain insurance, as well as avoid the high increases in premiums that would otherwise occur.

Further, we recognize that a healthy timber industry is compatible with a healthy forest. Any of us who drive by the intersection of Route 50 and 395 in Carson can see the timber stacked and ready for a budding sawmill to turn into lumber. While it is unfortunate a 2022 major forest fire that touched South Lake Tahoe spurred the creation of this mill, it is encouraging to know that dead and dying trees in our nearby forests will be converted into useable products while increasing the sustainability of our state and national forestlands in Nevada.

Third, California's law that does not allow insurance companies to pass along to customers the costs of re-insurance further compounds the problem. Re-insurance is a back-up system that protects insurance companies from paying out more than they can afford. Is it no wonder that AIG and Chubb decided not to renew thousands of policies in California because of the State's laws and high fire risk. Nevada needs to retain a system that allows insurers to purchase re-insurance and share the cost with their clients.

Fourth, the California Environmental Quality Act and its plethora of regulations has resulted in virtually no new housing construction in California. The lack of housing supply has increased the cost of existing housing and property insurers have raised their rates accordingly. Added California burdens of using organized labor wage rates and adding in low-income housing components, means when they are finally approved, new housing developments are built at above market costs. We have seen similar burdens added by our Nevada counties and legislature to new housing projects. We tax-payers need to push back to ensure that the supply of housing in our State remains strong and keeps our existing homes both affordable and insurable.

So often, California has shown us what not to do in Nevada. Let's heed these lessons and remind those who have recently moved here from California why they need to respect "The Nevada Way."





What is "Question 3" - Ranked Choice Voting?

anked choice voting is a system for counting

votes that gives voters the option to rank their choices in order of preference. If a voter likes candidate A, and would prefer candidate B over candidate C if their favorite (candidate A) did not win, they could rank the three candidates accordingly on their ballot (A > B > C).



How do votes get counted in such a system? There are multiple methods, but the most common one is the "alternative vote." During the alternative voting process, the candidate receiving a majority of first choice votes wins and the election is over. If no one wins a majority of votes, the ranked choices come into play using a computer program. In the most common form of ranked voting, the last-place candidate gets eliminated (i.e., the candidate with the fewest first choice votes), and the voters who chose that candidate as their first choice have their votes reallocated to their second choice. For example, if candidate A came in last place, the vote would go to candidate B. This process continues until a candidate achieves a majority of votes.

Why Not Use Ranked Choice Voting?

Some opponents of ranked choice voting dislike it for one of the same reasons its supporters promote it: it can weaken the far right or left wings of the two main political parties by diluting the power of very progressive or very conservative politicians and policies.

Complicated Process Results in Ballot
"Exhaustion" – Filling out a RCV ballot can
confuse voters. If voters do not use all of their
ranking choices this can lead to "ballot exhaustion"
— a drop off in the total number of votes being

counted in the later rounds of counting, in essence, a ballot is cast but does not count toward the end election result

Delayed Results - Another concern is the time it takes to count ranked choice ballots, which could lead to delayed results and a lack of confidence in the results

Decreased Voter Turnout – A 2016 Cato Institute study examined voter turnout in five elections from 1995 to 2011 and found that the adoption of RCV decreased voter turnout.

Jungle Primaries – Any registered voter, regardless of party, can cast a vote for their preferred candidate. The top five candidates advance to the November general election. Yes, this gives Democrats the ability to affect the Republican candidates that go on to the general election. RCV is used as a justification by the left to "give all voters a chance to vote in the primary election. What they don't tell you is that anyone CAN vote in the primary, party affiliation can be changed on the day of the vote by any voter to enable them to vote.

Many people feel that some cases RCV can lead to a person winning who doesn't have majority support.

The Washoe County GOP is strongly AGAINST ranked choice voting. It is confusing, can cause significant delays in determining the outcome of an election, and can (and does) cause a number of votes to drop out if incomplete or completed incorrectly. The source of the software used to rank the choices is another concern – who writes the software code, how is an election "verified" or results "recounted"? If ranked choice voting is approved in 2024, many believe that there will never be another Republican elected in the state. In 2022 "Question 3" regarding ranked choice voting passed narrowly, most Republicans believe that the language of the question was written to confuse voters. Top contributors in favor of passing ranked choice voting were George and Alex Soros.

How Mike Johnson Became Speaker "Through Prayer, Not Politics"

yebrows were raised when newly elected Speaker of the House Mike Johnson (R-La.) in his first address from the chair reminded the assembled Democratic and Republican members of the House of Representatives that the God of the Bible raised up each one of them for a purpose. "I want to tell all my colleagues here what I told the Republicans in that room last night: I don't believe there are any coincidences in a matter like this. I believe that scripture, the Bible, is very clear that God is the one that raises up those in authority. He raised up each of you. All of us. And I believe that God has allowed and ordained each and every one of us to be here at this specific moment," the Louisiana Republican said. He added, "This is my belief. I believe that each one of us has a huge responsibility today to use the gifts God has given us to serve the extraordinary people of this great nation, and they deserve it."

Those who know Mr. Johnson, a devout conservative Southern Baptist, however, weren't surprised by his allusion to verses in the Bible such as Daniel 2:21 that say the Creator raises up and deposes of political leaders: "He changes times and seasons; he removes kings and sets up kings; he gives wisdom to the wise and knowledge to those who have understanding."

A former Louisiana state representative who is now serving in his fourth term in Congress, Mr. Johnson, 51, and his wife, Kelly, have four children. Before his remarkable rise to the speakership, Mr. Johnson had served as chairman of the Republican Study Committee (RSC), which describes itself as "the intellectual arsenal of conservatism in the House." In addition, he was elected in January 2021 to a second term as vice-chairman of the House Republican Conference and he was a deputy whip under then-Speaker Kevin McCarthy (R-Calif.).

Prior to his political career, Mr. Johnson was the first member of his family to graduate from college, with a bachelor's in business administration from Louisiana State University (LSU) in 1995 and a law degree from LSU's Paul M. Herbert Law Center in 1998. He was elected president of the Christian Legal Society at LSU and subsequently became a successful constitutional law litigator.

In addition to his faith, Mr. Johnson is a classic Reagan conservative with a distinctly populist accent. On his official website is listed the congressman's "Seven Core Principles of Conservatism." Of that latter principle, Mr. Johnson explains: "Because all men are created equal and in the image of God, every human life has inestimable dignity and value, and every person should be measured only by the content of their character. A just government protects life, honors marriage and family as the primary institutions of a healthy society, and embraces the vital cultural influences of religion and morality. Public policy should always encourage education and emphasize the virtue of hard work as a pathway out ofpoverty, while public assistance programs should be reserved only for those who are truly in need. In America, everyone who plays by the rules should get a fair shot. By preserving these ideals, we will maintain the goodness of America that has been the secret to our greatness."
