
When the U.S. Constitution was drafted there was no provision made for political parties. Yet they sprung up naturally from the earliest days of our republic. In Federalist Paper No. 10 James Madison made a case for federalism based on the American tendency to form "factions." Surely, when you put one hundred citizens in a room you will not easily form consensus; everyone has a differing opinion. Madison was concerned that we avoid a tyranny of the majority. The rights of the minority to dissent should be respected. He wanted adoption of the U.S. Constitution because it protected those rights (i.e., representation in Congress and the Electoral College).

Years later, when Alexis de Tocqueville wrote *Democracy in America* (1832) one of the things he was amazed by was the energetic and somewhat chaotic nature of American business and politics. Although the form of government was representative, the government could not exist without the will of the people. "Americans of all ages, all stations of life, and all types of dispositions are forever forming associations," he wrote. Americans, at this point, no longer identified as Federalists and Anti-Federalist, but in 30 years they wouldn't be identified as Whigs and Democratic-Republicans either. By the Civil War we had the two major political parties as we identify them today.

We, ladies, identify as Republicans. Our role as a

club is to support our party's principles, support the party's candidates while running for office, helping them govern when in office, and providing a watchdog for government when out of power. We are going to have an interesting year. Our federal government, for the first time in years has a Republican President in Donald Trump and a Republican Congress. While they need our support, our greatest need is a bit closer to home. One vote shy of a supermajority, our state legislature is stacked against the Republicans. We must serve in this instance as the watchdog of our government. YOLANDA KNAAK, our Legislation Chair, along with her committee, will diligently follow various measures through the state legislature. We must do our part. She is looking for committee members to help with this task. Yolanda will be speaking at our February luncheon to simplify our responses to members of the legislature on impending legislation.

On a sad note, **TY COBB**, a longtime Nevada Republican and a titan of Republican politics in Nevada, died December 7th. He founded the National Security Forum and was CEO of the Northern Nevada network. He will be missed.



could be here should we find ourselves in a similar situation. Let's pray that this doesn't happen here! We sent several of our own equipment and personnel down there to help with crews from California.





Joe Biden's Disgraceful Departure

As Donald Trump was preparing to leave office in Januaryuary 2021, it was clear that Joe Biden's "victory" in the 2020 election was fabricated from three dark political strategies. Joe Biden's Disgraceful Departure

Biden's final actions while exiting the White House exemplified the corruption of his entire presidency. It is no small irony that Biden would leave office on Martin Luther King Day because, over the past five decades, Biden and his fellow Democrats have turned MLK's dream into a nightmare for tens of millions of Americans.

Biden's dark "oligarchy" farewell address was a bookend to a career of unmitigated lies, including the BIG Lie that Trump was backed by more billionaires than Harris. In fact, according to a preelection review of federal election records, "At least 83 billionaires – two of them centibillionaires with a net worth of more than \$100 billion each – are supporting Harris, while 52 billionaires, one a centibillionaire, back Trump."

Then there was all the dark money funneled into the Harris campaign by billionaire leftist George Soros and others who backed her after Nancy Pelosi and her fellow Democrat power-brokers booted Biden to the curb.

Biden's farewell remarks were a metaphorical caricature of the rise of a thuggish political oligarch on the public dole. Likewise, the Oval Office exit interview that followed was equally infused with lies. There were his delusional claims, including this whopper: "Compared to four years ago, America is stronger. ... During my presidency, I've increased America's power in every dimension." A day later, "President Democracy" attempted to rewrite our Constitution with a bizarre claim crafted by his leftist puppeteers that the Equal Rights Amendment is now the "law of the land."

But it was Biden's unpardonable pardons issued in his final weeks — and final minutes in office — that have drawn the most attention and fire.

Over the last 30 days, when most of the Leftmedia talkingheads and scribes were focused on whether Donald Trump would issue pardons to January 6 protesters, Joe Biden started his pardon party by issuing a get-out-of-jail-free card to Hunter Biden,

despite repeatedly promising he would never do that because "No one is above the law." That was just another entry to the



bottomless list of Biden lies over the course of his last 50 years.

Then, Biden commuted the sentences of 1,499 people and pardoned another 39 convicts to divert the news cycle attention from the corrupt pardon favor for his son. That was followed just before Christmas with his commuting the sentences of 37 of 40 federal death row inmates, some being the most evil people in federal custody.

Biden began the New Year commuting another 2,500 sentences.

Hours before leaving office, despite warnings from Demos not to issue preemptive pardons, Biden issued preemptive pardons for Anthony Fauci, GEN Mark Milley, and the J6 inquisitors, including witness-tampering former Rep. Liz Cheney. "I believe in the rule of law," said Biden, "but these are exceptional circumstances, and I cannot in good conscience do nothing."

Finally, just minutes before Trump took his oath of office, Biden extended pardons to his immediate family members – to the astonishment of many of Biden's Leftmedia defenders, including even CNN leftist Jake Tapper. Apparently, this exceeded even Tapper's tolerance for hypocrisy. He posted combined links to the Biden family pardons with a link to a 2020 CNN article just before Trump left office, about Biden's concern that Trump might issue preemptive pardons to family members (which he did not do). According to Biden then: "It concerns me in terms of what kind of precedent it sets and how the rest of the world looks (at) us as a nation of laws and justice. ... You're not going to see, uh, um, in our administration, that kind of approach to pardons."

President Trump and Border Czar Homan are returning illegals

resident Donald Trump and his team have hit the ground running in terms of fulfilling a major campaign promise — namely, cleaning up the border and deporting illegal aliens. As Border Czar Tom Homan recently stated, "It's not okay to violate the laws of this country. We have millions of people standing in line, taking the test, doing their background investigation, paying the fees that want to come in the right way. So if you're in the country illegally, you got a problem."

Last week, Trump deployed 1,500 troops to the southern border. These military personnel aren't there to help with paperwork; they are being dispatched to actually enforce our border laws and support the thousands of National Guardsmen and Customs and Border Patrol (CBP) agents already there. Since these troops are active duty, they cannot do the job of law enforcement in terms of making arrests or detaining anyone. They can, however, coordinate logistics and transportation with CBP, whose agents can make arrests. These 1,500 troops can also help erect barriers such as barbed wire fencing and other deterrents.

On the flip side, should President Trump enact the Insurrection Act of 1807, that would enable these troops to begin actually policing the border. That necessity will be assessed by Secretary of Defense Pete Hegseth and Secretary of Homeland Security Kristi Noem. They will issue a report in 90 days advising the president on his next steps to secure the border. In the meantime, Trump has also declared a national emergency at the border and classified drug cartels as terrorist organizations.

These actions could potentially free up the troops legally without triggering the Insurrection Act.

Border Czar Homan has called Chicago "ground zero" for immigration enforcement. Unfortunately, ICE's job is being made exponentially harder because of "sanctuary city" policies. That means ICE is on its own when it comes to apprehending illegal alien criminals, as local law enforcement won't (or can't) help them. ICE is also being barred from going into prisons and taking away illegals. On top of all that, Chicago Mayor Brandon Johnson is fearmongering by claiming ICE will enter public schools and arrest illegal immigrant children.

In probably the most hilarious development of the weekend, President Trump had to remind the president of Colombia who was boss. This past weekend, the United States sent two planes full of Colombian nationals back to their country as part of the deportations that are now underway. Colombia's unpopular socialist president, Gustavo Petro, adamantly refused to let the American planes land. The United States obtained clearance to fly them back to Colombia, and Petro's last-minute order forced the planes to turn around. So what did President Trump do? He threatened to slap Colombia with a 25% tariff on all goods coming into the United States. And if, after a week, President Petro still denies the return of illegals. then that tariff will be raised to 50%. By Sunday, Petro walked back his threat and even offered his presidential plane as one of the transports for the returning Colombians.

The American people are relieved that President Trump is rectifying what President Biden broke. Biden allowed an invasion at our southern border, created a humanitarian crisis, facilitated a nationwide rise in crime, and threatened the safety and security of our country by allowing millions of unvetted illegal aliens into the country. [Because of Trump's actions] we're back, and it's cause for celebration.

American Legislative History: Alien Enemies Act



Inacted by the 5th United States Congress and signed into law by President John Adams on July 6, 1798, The Alien Enemies Act (officially "An Act Respecting Alien Enemies") was passed to supplement the Alien Friends Act, granting the government additional powers to regulate noncitizens that would take effect in times of war." Under this law, the president could authorize the arrest, relocation, or deportation of any male over the age of 14 who hailed from a foreign enemy country. It also provided some legal protections for those subject to the law. Unlike the other acts, this act was largely unopposed by the Democratic-Republicans.

The Alien Enemies Act was not allowed to expire with the other Alien and Sedition Acts, and it remains in effect as Chapter 3, Sections 21–24 of Title 50 of the United States Code. President James Madison invoked the act against British nationals during the War of 1812. President Woodrow Wilson invoked the act against nationals of the Central Powers during World War I. In 1918, an amendment to the act struck the provision restricting the law to males.

On December 7, 1941, in response to the bombing of Pearl Harbor, President Franklin D. Roosevelt used the authority of the revised Alien Enemies Act to issue presidential proclamations #2525 (Alien Enemies – Japanese), #2526 (Alien Enemies – German), and #2527 (Alien Enemies – Italian), to apprehend, restrain, secure, and remove Japanese, German, and Italian non-citizens. Roosevelt later cited further wartime powers to issue Executive Order 9066, which interned Japanese Americans using powers unrelated to the Alien Enemies Act. Hostilities with Germany and Italy ended in May 1945, and President Harry S. Truman issued presidential proclamation #2655 on July 14. The

proclamation gave the attorney general authority regarding enemy aliens within the continental United States, to decide whether they are "dangerous to the public peace and safety of the United States," to order them removed, and to create regulations governing their removal, citing the Alien Enemies Act. On September 8, 1945, Truman issued presidential proclamation #2662, which authorized the secretary of state to remove enemy aliens that had been sent to the United States from Latin American countries. On April 10, 1946, Truman issued presidential proclamation #2685, which modified the previous proclamation, and set a 30-day deadline for removal.

In Ludecke v. Watkins (1948), the Supreme Court interpreted the time of release under the Alien Enemies Act. German alien Kurt G. W. Lüdecke was detained on December 8, 1941, under Proclamation 2526, and continued to be held after cessation of hostilities. In 1947, Ludecke petitioned for a writ of habeas corpus to order his release, after the Attorney General ordered him deported. The court ruled 5-4 to release Ludecke but also found that the Alien Enemies Act allowed for detainment beyond the time hostilities ceased until an actual treaty was signed with the hostile nation or government.

On September 20, 2024, Donald Trump



announced that if elected president for a second term he would invoke the Alien Enemies Act of 1798 to expedite the removal of noncitizens and criminal networks operating in the United States.


Incline Village-Crystal Bay Republican Women Vision and Mission Statement
